History Note:

This company was founded as the Methodist Publishing Company in 1874 and published the Michigan Christian Advocate until 2010 when it became a website.

Scope Note:

The collection contains the original articles of incorporation and early minutes of the company, reports, legal documents, property records, and an extensive set of clippings of obituaries from the magazine.

Extent:

4.8 linear feet (ca. 9,600 pages)
