## Saginaw State Street United Methodist Church

### History Note:

This church was organized in 1948. Some members of the new church came from Saginaw Stephens Street, which was closing around that time. Money from the sale of the Stephens Street church was donated to the new church. The church discontinued 30 June 2019.

### Scope Note:

In addition to a History File on the church, the collection contains meeting minutes of various committees, financial reports, directories, and a book of minutes and reports from the Saginaw Stephens Street church.

### Extent:

4.4 linear feet (ca. 8,800 pages)

### Access Restrictions:

The collection is open to research.
